INVITING APPLICATIONS FOR ICAR NATIONAL FELLOWS

NOTIFICATION

Concept notes are invited for five vacant positions of ICAR-National Fellows from the Scientists active in research, working in ICAR-Agricultural University system in the capacity of Professor / Principal Scientist / Associate Professors / Senior Scientists / Research Scientists in equivalent positions, holding the scientific position for a minimum period of 10 years, out of which three years should be in the capacity of Senior Scientist or equivalent position, and age not exceeding 52 years as on 14.01.2020. Applicant must have demonstrated excellence through individual contributions and achievements in agricultural research. The applicant must have made significant contributions in the form of knowledge and technology generation as evidenced by published work in NAAS rated journals, product/process/methodology, released and notified variety/breed/stocks, innovations as patents/protections etc.

The ICAR National Fellow would be appointed in the Pay Band-IV of Rs. 37,400 – 67,000 with Research Grade Pay of Rs. 10,000/- per month which has been revised vide Council's order no. 1(4)/2017-Per.IV dated 27.03.2018. An ICAR National Fellow will be appointed for an initial tenure of five years, which can be extended for one more, i.e., second tenure of five years subject to the quality performance. In exceptional cases third and final term of five years or until superannuation could be extended. In addition, the contingent funds for required staff, equipments and operational assistance would also be provided by the ICAR through the institution where the scientist takes up the research work (visit ICAR Website: http://www.icar.org.in/ for detailed guidelines of ICAR National Fellowships dated 28th Jan, 2019).

A two-step process for inviting nominations will be followed,(a) Call for concept note about the proposed research programme from the eligible candidates, and (b) Call for detailed project proposal from the shortlisted candidates based on the merit of the concept note. The concept note (hard copy) may be submitted in the prescribed proforma (Annexure-I) through proper channel so as to reach the office of Deputy Director General (Agricultural Education), ICAR, Krishi Anusandhan Bhavan-II, Pusa, New Delhi-110012, on or before 14.01.2020 latest by 5.30 P.M. It may please be noted that canvassing of any kind will be treated as disqualification. Nominations received after due date and time will not be considered and summarily rejected.
