Proceedings of the Annual Conference of Vice Chancellors of Agricultural Universities and ICAR directors held during 22-23, January, 2016, at NASC Complex, DPS Marg, Pusa, New Delhi

#### **INAUGURAL SESSION**

Annual Conference of Vice-Chancellors (VCs) of the Agricultural Universities (AUs) and ICAR Directors was held at the National Agricultural Science Centre, Dev Prakash Shastri Marg, New Delhi, during 22-23, January, 2016. The Vice Chancellors of the Agricultural Universities (AUs), Directors of ICAR Institutes, and Senior ICAR Officials attended the interactive session. This conference provided an excellent opportunity for interaction and effective collaboration between AUs & ICAR institutes for strengthening and quality assurance of the higher agricultural education.

Dr. S. Ayyappan, Secretary, DARE & DG, ICAR extended warm welcome to the Chief Guest Shri Radha Mohan Singh, Union Minister of Agriculture & Farmer's Welfare and to all the other dignitaries and participants of the Conference. As the occasion was 119<sup>th</sup> birth anniversary, of Netaji Subash Chandra Bose, the dignitaries offered rich floral tributes to the great leader.

Thereafter, Secretary, DARE & DG, ICAR, presented the salient achievements and activities of the NARES and appreciated the co-operation being extended by the universities from time to time and hoped to breach the bar in research for achieving higher quality of education so that SAUs become most sought after destination for the talented students. The universities across the country should collaborate to take on emerging challenges and new programmes for increasing productivity, profitability and sustainability of the farming systems.

He also informed about the Conference of the young scientists who will be serving till 2050, celebrations of golden jubilee of green revolution, launching of Kisan Channel and release of 93 climate resilient varieties developed by NARES. He further informed that during the Year of Soils, Soil Health Cards were distributed to the farmers.

The Hon'ble Union Minister of Agriculture & Farmer's Welfare, in his inaugural address said that Netaji left us a legacy of ideas, ideals and dreams and the most precious item in that legacy is his generous and imaginative approach towards achieving unity by respecting difference. The chief guest also emphasized the importance of distribution of soil health cards to prevent excessive use of fertilizers and stated that progress of "Mera Gaon Mera Gaurav" must be monitored to study its impact. It was also informed that to improve the indigenous livestock the government has allocated Rs. 500 crore and work has been initiated in 27 states and establishment of the National Breeding Centre has been finalized in Bhopal to increase milk production. He appreciated the tradition of awards being given to progressive farmers. Sh. Neelam Dutta, a progressive and innovative organic farmer from the Biswanath Charali, Sonitpur, Assam was awarded Haldhar Organic Farmer Award, 2014. The Hon'ble Minister desired that to encourage marginal farmers, appreciation letters/awards may be given to them on the occasion of foundation Day of the Institute/ KVKs. He expressed hope that deliberations during this conference will pave the way for the prosperity of farms & farmers.

The three universities viz. University of Agricultural Sciences, Dharwad, University of Agricultural Sciences, Bengaluru, Orissa University of Agriculture & Technology, Bhubaneswar, were awarded first, second and third position, respectively, for achieving excellence in AIEEA-PG examination conducted at all India level. Among the categories of large and small ICAR Institutes, the best annual report award 2014-15, was bestowed upon ICAR-Central Marine Fisheries Research Institute, Kerala and ICAR-National Institute of Agricultural Economics and Policy Research, respectively. Various CDs and books were also released on this occasion by the Hon'ble Union Minister.

Shri Chabbilendra Roul, Additional Secy. DARE & Secretary ICAR, proposed the vote of thanks.

### **PLENARY SESSION**

Dr .N.S. Rathore, Deputy Director General (Agril. Education), ICAR extended the warm welcome to the august gathering. The new VCs were also introduced. He informed that guidelines for the various components have been firmed up. He complimented the VCs for the progress being made in strengthening the higher

agricultural education and urged them to monitor the budget and submit the reports and other necessary documents on time for smooth functioning. He also mentioned linking of grant with accreditation and launching of "Student READY" component and requested the VCs to be proactive. He praised the efforts of the Dean's in preparing the draft report of Fifth Deans' Committee.

Shri C. Roul, Additional secretary DARE & Secretary ICAR, lauded the concerted efforts and role of agricultural scientists in providing food security to the nation and shaping the future of the country. He mentioned that fruits of the green revolution were realized due to the sincere efforts of researchers, extension workers and policy makers. He emphasized that this is not the time to be complacent but, in fact we have to work towards making farming a profitable venture and develop it as agribusiness. He also emphasized on strengthening agriculture education so as to have quality human resources for strengthening research and technology programmes with an ultimate goal of increasing productivity. Our focus should be on creating an ecosystem which is economically viable and profitable for farmer and develop commercially viable cropping systems. He expressed that farming must be developed as capital system approach with primary and secondary processing facilities, as youth will be attracted to agriculture, only if, the package is commercially viable.

Shri S.K. Singh, Additional Secretary & FA, DARE, was of the view that resources have to be optimally utilized in transparent manner and urged the Vice Chancellors to ensure that all the formalities are adhered to. He informed that guidelines/criteria have been uploaded on the Council's website and all the universities can view them and shortcomings, if any, will be revised in due course. He mentioned that meeting of comptrollers was fruitful and requested the VCs to ensure that all formalities are adhered to and the resources are utilized optimally in transparent manner. He requested that all universities must get themselves registered on CPMS/PMS portal.

Dr. M.C. Varshneya, President IAUA, in his remarks briefed the activities of the IAUA. He appreciated the role of ICAR in supporting higher agricultural education. He informed that there existed close collaboration and coordination among member AUs of IAUA and lauded the all-round agriculture development under the aegis of

ICAR. He was of the view, that weaker and new universities should be supported more by the Council.

Dr. Gurbachan Singh, Chairman, ASRB, briefed about the efforts of ASRB in conducting interviews on time and efforts towards filing up of vacancies. He informed about the revised score card and application form. He also mentioned about the digitization process initiated in ASRB, and the revised pattern of ARS exam.

Dr S. Ayyappan, Secretary, DARE & DG, ICAR, welcomed everyone and emphasized the need to work in partnership with Agricultural universities. advocated that way forward should be through competitive modes and grants should be linked to performance in various spheres. He mentioned that Golden jubilee of the Green Revolution was celebrated and added that, as per present scenario, by 2030 the productivity may increase by 40%, leading to decrease of rural poverty and hunger by 30%. In his view, the GM & hybrid technologies, restoration of soil health, farm mechanization and quality human resource will effectively contribute towards next green revolution. The house was apprised about the proactive measures taken by ICAR to tackle deficient monsoon last year like creating awareness, issuing advisories, contingency plans, seed store, rain water harvesting, in situ rain water management etc. The renewed thrust of the government in higher agricultural education was also highlighted. He emphasized that concept of innovation led growth in agriculture is essential for sustainability, and informed that starting of Nanocellulose Pilot Plant in CIRCOT, Mumbai was a step towards GOI efforts towards 'Make in India'. The information regarding new initiatives launched by ICAR viz. मेरा गाँव मेरा गौरव, Farmer FIRST, Student READY, ARYA, Agri-Tech Foresight Centre, Extramural Funding, National Agricultural Incubation Fund etc. was shared with the august gathering. He stated that each university may adopt a single village to showcase the impact of the technologies developed. He emphasized that the work and technologies must leave a roadmap for the younger generation.

# Agenda 3.6: Minimum Standards of Higher Agricultural Education for Private Colleges affiliated to State Agricultural Universities.

All the above items were covered during presentation of the Dean's Committee report by ADG (EQR).

Prof. R. B. Singh, Chairman, Fifth Deans' Committee, in his remarks stated that dynamic curriculum is must for excellence and relevance of agricultural education for prosperous India. He said Green, White, Yellow and Blue Revolutions have been made possible through quality Education, Research and Extension. The challenges being faced by the farming community were also highlighted by him. He was of the

view that the challenges for Agricultural Researchers and Educationists are to develop innovations that offer sustainable intensification of production, profitability and social attractiveness to agriculture as a profession, ecosystem Services, and prediction of future demands and match them and emphasized that third generation universities should take up zero hunger challenge. He also discussed about building up of the *Unnat Pathyakarm*-leading to *Unnat Krishi shiksha* which can further lead to *Unnat Krishi & Kisan* and ultimately *Unnat Bharat*. According to him, curriculum development should be driven by expertise in field, external advisory groups etc.

Thereafter, salient points of the draft report were presented by Dr. G. Venkateshwarlu, ADG (EQR).

The soft copy of the Deans' Committee report will be sent to all VCs and all the VCs may submit the feedback after discussion with the faculty within two month's time.

## Agenda 3.3: Accreditation of SAUs/DUs/CAUs for quality assurance

The accreditation will be mandatory for release of Grant-in-Aid to agricultural universities and only the academic programmes recommended by Deans' Committee and PG course regulations committee will be considered for accreditation Filling of 15% and 25% quota in UG and PG programmes, respectively in agricultural universities through All India Entrance Examination for Admission (IAEEA) would be allowed only for accredited colleges from the academic year 2016-17.

The soil testing laboratories spread across the country and operational under KVKs, SAUs ICAR institutes have been identified to train 50 youth each in the area of soil and water management, collection and analysis of soil samples at each centre. 4923 applications were received for registering the varieties and 705 certificates

were issued covering 67 crop species. One of the function of the Authority is to

document, index and catalogue the farmers' varieties. He informed that Authority

supports and reward farmers, particularly the tribal and rural communities engaged

in conservation, improvement and preservation of genetic resources of economic

plants and their wild relatives, particularly in areas identified as agro-biodiversity

hotspots. KVKs may spread awareness among farmers if they are conserving

varieties to apply for awards from PPVFRA.

10+2+5+2 for Doctoral degree. Candidates with 3 years Bachelor's degree are not eligible for admission through AIEEA-PG-2016 and AICE-SRF (PGS) - 2016, except for four ICAR DU's.

## Agenda 6.8: 100% Admission to ICAR-DU's only through their entrance exam for Ph.D. programme for 2016 admission

ICAR – DU's will fill up 100% of seats for Ph.D. admissions through the exam conducted by them. No seat allotment/SRF-PGS award by ICAR through AICE-SRF (PGS) for 4 DU's for Ph.D. Program.

# Agenda 6.9: Filling up of 15% seats for UG and 25% seats for M.Sc. &Ph.D. discretion of powers rests only with ICAR- SAU's to follow

All the SAUs were advised to follow ICAR guidelines for filling up of 15% of seats for U.G. and 25% seats for M.Sc. & Ph.D. admissions. Unlike previous years, only 15% of seats for B.Tech (Dairy Tech) programme at NDRI will be filled through AIEEA-UG-2016 and 85% to be filled by NDRI, Karnal.

sustaining and contingency is provided as per approved norms only during the first

two years of establishment.

Enhancing Contingencies under AICRP schemes, Sanctioning of New AICRP schemes, provision of allowances in some AICRP schemes in some schemes funds are not provided for allowances like LTC, medical, CCA etc., Timely release of funds for AICRP projects and promotions of Sr. technical Assistant to T-7-8 and T-9 as per ICAR Technical service rulesetc.

- For the agenda items pertaining to AICRPs it was suggested that ICAR guidelines for AICRP projects may be followed.
- Transfer of scientists/SMS from AICRPs to universities is not permitted without the concurrence of Project Coordinator

### **ACTION POINTS**

- No funding from the Central scheme for the universities, if not accreditated, from the financial year 2016-17.
- Timely submission of following documents by the Universities in the prescribed format:
  - i. Proposals along with checklists
  - ii. Annual Progress Report
  - iii. Utilization Certificate (UC)
  - iv. NET Essentiality Letter
  - v. Audited Utilization Certificate (AUC)
  - vi. Work Completion Certificate
- The universities may submit the list of the identified climate resilient varieties and submit the data base of such varieties to the Council.

- Universities may start Media Cell for Science communication and support will be provided from the Council.
- Vice Chancellors may critically look at the proposals submitted by the universities and proposals may be submitted in challenging areas so that faculty, university and country is benefited by extramural funding proposals.
- Movement of faculty across AUs to be encouraged
- Idle time of the AICRP scientists to be utilized for teaching so as to effectively address the faculty shortage.
- Land utilization pattern in precise mode to be taken up
- The universities may indicate the number of soil health laboratories that could be used for soil Health analysis
- To emphasize the use of technologies the showcasing of these technologies and results obtained may be demonstrated in a particular village.
- The universities may also submit proposals for establishing new KVKs as 109 new KVKs can be established.
- There should be a robust set of performance indicators for the PME Cell to prioritize, monitor and evaluate the outputs and outcome in all schemes and programmes.
- Location specific Farming System Models to be developed, and DDG (NRM)
  may bring out compiled compendium with duly worked out economics of
  successful model.
- Discipline wise meetings of the Deans may be held every two years.
- NDRI may submit a report on the progress of Sahiwal breed & its associated aspects.
- ICAR Institutes/ KVKs may felicitate marginal farmers during their Foundation Day celebrations.
